

For the CSA STAR Level 2 certification, you must be ISO/IEC 27001 certified, or you can get both the ISO/IEC 27001 certification and the CSA STAR certification simultaneously. The CSA STAR certificate will have the same expiration date as your ISO/IEC 27001 certificate.

In addition, your organization must complete the **CAIQv4 and CCM** documents - the required Consensus Assessment Initiative Questionnaire (CAIQ) and the Cloud Controls Matrix (CCM) that will be used to confirm your compliance during a third-party audit. MSECB will take care of everything else.

Upon verification that your organization conforms with the requirements of the CSA STAR, we will issue a certificate. This certification is then maintained through regularly scheduled annual surveillance audits, with the recertification audit being conducted on a triennial basis.
